This Board having well considered the severall particulars in y^e Representation, And forasmuch as one of the ~~Persons~~ depu^{ty}ed by the sd Doctor Payne is dead and the other absolutely Refuses to be concerned therewith it being a Judiciall Office - Ordered thereupon that M^r Henckem Cheseloyne the Petitioner continue to Act in the sd Office as formerly till further Order or until their Maj^{ty} pleasure be knowne therein But whereas Compla^{ints} have been made that some of the Deputy Comisarys have been guilty of extorting Unjust fees from the People the said M^r Cheseloyne therefore is hereby Required to take care that his Deputies conforme themselves in taking of fees according to Law his Exce^{ty} being well satisfied as to his part

October the 18th 1694

Commission issued continuing M^r Cheseloyne Comisary - W^m Mitchell

M^r Cheseloyne appearing at the Board humbly desires his Exce^{ty} (Seeing he is favourably continued in the Office of Comisary) that Comis^{ion} may Issue Under the Broad Scale for the same

Ordered that a Commission Issue accordingly to continue during pleasure whereupon was prepared a Commission pursuant thereto w^{ch} being read was sign^d by his Exce^{ty} and pass^d the Broad Scale of the Province.
