Maries County Gent^l are bound and firmly bound unto the Ex^{ors} Francis Nicholson Esq^r Cap^t Gen^l Govern^r in Chief of this Hon^{ble} Ma^{ty} Province of Maryland in the full sume of five hundred pounds good and Lawfull Money of England to be paid to the said Francis Nicholson his heirs or Successors Govern^{rs} of Maryland so the which paym^t well and truly to be made wee bind our selves our heirs Ex^{ors} and Adm^{ors} jointly and severally for & in the whole firmly by those presents

The Condition of this Obligation is such that whereas the above mentioned Francis Nicholson Esq^r Govern^r of Maryland as aforesaid this day granted unto the above bound S^r Thomas Laurence a permitt to transport himselfe out of this Province with direction to all Ma^{ty} of Ships or other vessels that they may safely transport the said S^r Thomas Laurence as aforesaid in as much as his said Ex^{ors} Francis Nicholson Esq^r had taken sufficient caution & security for the paym^t of such Debt (if any) as the said S^r Thomas Laurence doth owe in this Province according to the Act of Assembly of this Province If therefore the said S^r Thomas Laurence and Robert Mason or either of them their heirs or Assigns shall in any respects Incommitt the said Ex^{ors} Francis Nicholson Esq^r for his granting the said permitt or License to the said S^r Thomas Laurence according to the tenor of the said Act of Assembly that then this Obligation shall be void or else to stand in full force and virtue in Law.
