*Additional Orders and Instructions Power and Authority to be  
Observed and Pursued By Our Beloved Brother the Honourable  
Benedict Leonard Calvert Our Lieutenant Governour of  
Our Province of Maryland.*

*Given by Us at London this Thirtieth Day of  
January Annoq; Domini 1729*

*You are not upon any Account whatsoever to pass or Assent to any Act of an  
Assembly for the Future by which the present Provision that is made for the Clergy  
in a Act Entituled an Act for the Establishment of Religious Worship may be in any  
degree taken away altered or diminished.*

*As I understand there have been several Acts of late past for dividing and  
dismembering Parishes of the Province by which the Incumbents have unjustly lost great  
part of their Income, I think it necessary to give you positive Directions not to pass any Act  
for the future by which any Parish may be divided or any of the profits or provisions  
made for the Clergy may be taken away or given to others during the Life of the  
Incumbent for the time being without his consent.*

*And as I have been likewise Informed That private Acts have been frequently  
past in the Province without notice to or privity of the Persons concerned. You are  
for the future not to Assent to any private Act whereby the particular property of  
Persons is any ways taken away or concerned without regular notice to all Parties  
interested and liberty given them to make their defence.*

*You are likewise to publish and Enter all these Instructions on Record  
according to your Form.*

*Charles absolute Lord and Proprietary of the Province of Maryland and  
Avalon, Ford Baron of Baltimore &c. To Our Right Trusty and Dearly beloved  
Brother the Honourable Benedict Leonard Calvert Esq; Our Lieutenant Governour  
of Our said Province of Maryland, and to Our Right Trusty and well beloved, the Upper  
and Lower Houses of Our Generall Assembly there, and to all Others in Our said Province  
of Maryland for the time being Greeting Whereas at a Sessions of Assembly begun and  
held at Annapolis in Our said Province of Maryland the Third Day of October, and  
ending the Second Day of November in the Fourteenth Year of Our Dominion Over  
the said Province, Annoq; Domini 1728 An Act, Entituled An Act for Ascertaining  
the form of the Oath of Judge or Justice, passed into a Law. On due Consideration  
thereof, We have thought fit to Dissent to the said Act, and do hereby declare the  
said Act Null, Void and of no effect. Given under Our hand and Seal at Arms  
at London this Thirtieth Day of January in the Fifteenth Year of Our Dominion  
Over the said Province, Annoq; Domini 1729.*
