

Governors of the respective Provinces of Maryland & Pennsylvania.
For the time being do not upon pain of Incurring his Majesty's highest
 displeasure & some other Summ'd Riots or other Outrageous Disorders
 ever to be committed on the Borders of the respective Provinces but that
 they do immediately put a stop thereto and use their utmost endeavours
 to procure peace & good Order amongst all his Majesty's Subjects under
 their Government inhabiting the said Borders And as a means to procure
 peace & tranquillity on the said Borders his Majesty did thereby join
 the said Governors that they do not make grants of any part of the Lands
 in Controversy between the Proprietaries respectively nor of any part of the three
 said Counties commonly call'd New Castle Kent & Sussex nor permit any
 person to settle there or ever to attempt to make a settlement thereon till his
 Majesty's Pleasure should be further signified And his Majesty was further
 pleas'd to direct that that ^{copy} Certificate Duplicates thereof should be deliver'd
 to the Proprietaries of the said Provinces who are hereby required to trans-
 mit the same forthwith to the Governors of the said respective Provinces
 accordingly which Royal Order and Command being but just received by me
 I have with the advice of his Majesty's Council of State thought fit
 to immediately to publish and proclaim the same as aforesaid in Order
 that every of his Majesty's Subjects may have due and exact ^{Notice} thereof &
 govern themselves accordingly & for the more perfect Obedience to his Majesty's
 Will & Pleasure all Magistrates, Sheriffs, Surveyors, Officers
 & other persons Inhabitants of this Province are hereby strictly En-
 join'd & Commanded not only to prevent discourage and discountenance
 as much as they can any Summ'd Riots or other Outrageous Disorders
 on the Borders aforesaid or any future Settlements in the Places aforesaid
 but also from time to time to give immediate Notice to this Government
 of any such Summ'd Riot or other outrageous Disorder or any future
 Settlement or Attempt to make such future Settlement in any of the
 parts or places aforesaid in order that proper Measures may be taken
 for the putting a stop to suppressing or punishing the same & exacting
 the most perfect & full Obedience to his Majesty's said Royal Order & that
 none may pretend ignorance of his Majesty's Commands in the Premis-
 ses & every the Sheriffs of this Province are hereby strictly enjoy-
 n'd & Commanded to publish this Proclamation forthwith in their
 respective Counties not only by reading the same but also by immediately
 causing Copies thereof to be put in the most publick places in their respective
 Counties And that all & every the several County Courts to be held from
 & after the publication hereof they & every of them shall read & publish
 this Proclamation & so continue to read & publish the same at all & every
 the succeeding Courts in their respective Counties until they shall receive
 further Order to the contrary Given at the City of Annapolis this Twenty
 first day of November in the Twenty third Year of his Majesty's Domi-
 nion Annoque Domini 1737
