If that was what they went on, do assure you they were greatly taken for now tell you upon my Reputation that the fellow supported a good Character not only with me but with all the Neighbors where I resided. Now Sir as I am informed you intend to unapplies every own device you would lay the poor Fellow's case before His Excellency, And make no doubt from his known Goodness and Mercy will grant the poor fellow his Pardon and that without Intercession that being a matter I must excuse from as I cant think he in any sort deserves it.

In consideration of the above Letter and Recommendation of the Justices His Excellency with the Advice of that Board was pleased to Order that a Pardon should issue for the aforesaid Negro Robin, which was issued accordingly.

And the following Relation of Sunday Justices of Frederick County

To His Excellency Horatio Sharpe Esq<sup>r</sup> Governor and Commander in Chief in and over the Province of Maryland.

The Relation of the Subscribing Magistrates of Frederick County.

Most humbly sheweth That your Petitioners with great sorrow and Regret find themselves obliged to accuse two of their own Members of a scandalous Abuse of that Power which your Excellency hath thought proper to intrust them with in joint Commission with your Petitioners.

That without consulting upon other Irregularities, your Petitioners will confine themselves at present to the Information they have received of Capt. Evan Shelby, and Mr. Joseph Warford, in a Case of Fornication, as follows.

That a certain Catharine Whale, Daughter of Conrad Wheate, on the Month of September last charged Thomas Hynes, in Bath, before Capt. Thomas Price, one of his Lordships Justices of this County, with being the Father of her Bastard Child. Whereupon Capt. Price took Recognition for her appearance at November Court, and also for the same appearance and made return thereof accordingly.

That the said Hynes absented at the said November Court, but the young Woman not appearing, the matter was respite till March Court following.

That Hynes in the interim applied to Capt. Evan Shelby for a Warrant to take the Child from the said Catharine its Mother, which was granted in the form of a Search Warrant for Stolen Goods, and in substance thereof, on the 2d December Barnabas Johnson constable of Linton Hundred, with five men, went to the House of Conrad Wheate, and after calling for Whiskey, and making other Retences, at length demanded of Conrad Wheate to deliver up his Daughter & Child, pretending they had an Order of Court for it. Which Wheate demanding to see the Order, and finding the same only to be an Order of Capt. Price, refused to comply with, as his Daughter was under Recognition already. Upon
