 Emission in lieu of seven thousand one hundred and thirty six Pounds, six shillings &
 ten pence half penny to be deliv^d over to John Crawling & Co. paid by the audit.
 That the said Treasurer pay to John Bullon Esq^r one thousand, two
 hundred and thirty seven Pounds on Account.
 Samuel T. Wright Esq^r elected a Member of the Council to the Governor agree
 and ordered a certificate of his Qualification & took his Seat accordingly.
