

Wednesday 20th December 1780

Ordered that the Western show Treasurer pay to John Callahan three pounds, six shillings and seven pence half penny of the new Emifion value of one hundred and thirty three pounds, five shillings due him per Account passed by the Depty Aud.

That the said Treasurer pay to Joseph Whistler seven pounds and seven pence half penny of the same Emifion value of Two hundred and eighty one pounds, five shillings for one and a half days hire of his Boat to look out whilst the Enemy were in Patuxent and Choptank Rivers. —

That the said Treasurer pay to John H Stone Esq^r one hundred pounds of the same Emifion on Account. —

That the said Treasurer pay to His Excellency Thomas Am Lee Esquire one hundred pounds of the same Emifion on Account. —

That the said Treasurer pay to Ensign John S. Lowe one pound, thirteen shillings of the same Emifion value of sixty six pounds due him per Ac^t passed by the Depty Aud.

That the said Treasurer pay to Frederick Geimar Ten pounds, fourteen shillings and six pence of the same Emifion value of four hundred and twenty nine pounds due him per Account passed by the Aud. Gen^l. —

That the said Treasurer pay to John H Stone Esquire to be delivered to John McLeod sixty seven hhd^s of Tobacco weighing fifty five thousand eight hundred and seventy pounds net to be by him accounted for at fifty five pounds prime per c^t.

That the Spring Commissary deliver to Ensign John S. Lowe, four gallons of Rum sixteen pounds of Sugar and nine pounds of Coffee Stores due him for the Month of October and November. —

Thursday 21st December 1780.

Ordered that the Western show Treasurer pay to Captain James Somerville of the sixth Regim^t five pounds five shillings and nine pence of the new Emifion value of two hundred and eleven pounds ten shillings due him for stores per Ac^t passed by the Depty Aud.

That the Spring Commissary deliver to the said Capt James Somerville seventeen and a half gallons of Rum, twenty nine and a half pounds of Coffee and forty eight pounds of Sugar due him to the first of January next. —

That the Commissary of Stores deliver to the said Capt James Somerville Cloth and Trimmings for a suit of Cloaths and Linen for two Shirts and also to James Murphy a married Soldier of the first Regiment one suit of Cloaths one pair of Stockings one pair of Shoes and two Shirts. —

Friday 22nd December 1780.

Ordered that the Western show Treasurer pay to Daniel Carroll Esquire Two pounds fifteen shillings and three pence of the new Emifion value of one hundred and twelve pounds, ten shillings to be delivered over to Margaret Chalking due her per Account passed by the Depty Aud. —

That the said Treasurer pay to Thomas Johnson jun^r one hundred and sixty pounds of the same Emifion to be delivered over to George P. Keepers on Ac^t.

That the said Treasurer pay to Capt Archibald Gordon of the Regim^t Extra, ten pounds nineteen shillings of the same Emifion value of four hundred and thirty six pounds due him per Account passed by the Aud Gen^l. —
