That the Lieutenant of Ann & Princes Georges County be requested to furnish immediately a Guard of Militia to consist of one Captain and two privates to escort fifty thousand Dollars of the new Bills emitted by Congress to the Treasurer of the Eastern Shore.

Monday 8th January 1781. —

Ordered That the Western Shore Treasurer pay to William Hutchinson Two hundred pounds of the new Emission to be delivered over to John I. Bowers on account

That the said Treasurer pay to Daniel Canoll Esquire one hundred and seventy six pounds of the same Emission value of an Order of the 14th July last in his favor for seven thousand pounds, which said order is now returned. —

That the said Treasurer pay to James Brice Esquire twenty four pounds, ten shillings of the same Emission on account

That the said Treasurer pay to John King Eleven pounds six shillings of the same Emission value of four hundred and fifty pounds due him per Act passed by the Depty and. —

That the said Treasurer pay to Lieut John McFaden three pounds four shillings and one penny half penny of the same Emission value of one hundred and twenty eight pounds, six shillings and three pence passed by the said Genl.

That the said Treasurer pay to John Amis six pounds, one shilling and three pence of the same Emission value of two hundred and two pounds ten shillings and three pence passed by the said Genl. —

That the said Treasurer pay to Joseph Middleton nineteen pounds four shillings and four pence half penny of the same Emission value of two thousand and fifty Dollars due him per account passed by the said Genl. —

That the said Treasurer pay to Captain John Pitt fourteen pounds one shilling and three pence of the same Emission value of fifteen hundred Dollars due him per account passed by the said Genl. —

That the said Treasurer pay to Captain Gilbert Middleton one hundred and seventeen pounds, six shillings and three pence of the same Emission value of Four thousand, six hundred and ninety two pounds ten shillings due him per account passed by the said Generals. —

That the said Treasurer deliver to Doct. Henry Schmebely twenty chests of Tobacco, weighing seventeen thousand, seven hundred and thirty nine pounds net to be by him delivered over to George Muddock Esquire on account

That the Spring Commissary deliver to the said Doct. Henry Schmebely six days rations for six men who bro^t Waggons from Tid^e & Washington Counties and also to Lieut James McFaden of Capt Browns Company of twelve Gallons of Rum and fifteen pounds of sugar value for the year 1780. —
