That the western shore Treasurer pay to William Biggs two hundred and twenty five pounds eighteen shillings and nine pence of the new Emission to be delivered to Clarke and Biggs for one hundred and twenty and a half yards Scotch Linen purchased of them by the Governor and formed for the Army & delivered to Mr. Humphreys

That the said Treasurer pay to Hannah May one pound seven shillings and six pence of the same Emission in lieu of seventy five pounds due her per Account passed by the Depty Aud. —

That the said Treasurer pay to William Kemble Esq^r five pounds one shilling and three pence three farthings of the same Emission in lieu of two hundred and two pounds twelve shillings and six pence due him per Ac^t. passed by the Aud. General. —

That the Commissary of Stores deliver to John Bullen eight blankets and coarse linen for six Matresses for the soldiers wounded in the *Porpoise*. —

That Captain Beniah Maybury and Mr. John Ball be requested to survey the Sloop *Porpoise*, belonging to Messrs Wallaw, Davidson and Steward and report to this Board the Damage she sustained in a late action with a British Privateer. —

Warrant issued directed to John Bullen Esquire to impregne Waggons to remove the public Records, in pursuance of a Resolution of the Gen^l Assembly of 15th Dec^r.
