Whereas it appears to this Board by a Letter of the 6th Instant sent from John Murdock and Richard Thompson Esquires of Montgomery County, that Robert Edgins of the State of Georgia and Brigadier General in the Continental Army and Col^o Leonard Marbury of the same State, and also by a Letter from Col^o Charles of the 6th Instant that William Brown, William Gibbons and Matthew Griffin of the State aforesaid was driven from that State by the Enemy and have settled in this State, that they have taken the Oath of Allegiance to the State of Georgia and have done every thing that good Citizens could do in support of their Country, they have the Approbation of the Board to settle in this State. —

Whereas we are informed that Benjamin Shockley has in a violent and outrageous Manner resisted the late Sheriff of Worcester County in the execution of the Law and compelled him to resign his said Office whereby together with the general Conduct and Conversation of the said Benjamin Shockley in drinking Swear to the King of Great Britain and boasting that they expect ample satisfaction for what had been taken from them, Dissatisfaction is spread amongst the Subjects of this State and the disaffected and evil disposed are encouraged to oppose the Government and its Laws, The Lieutenant of Worcester County is hereby empowered, required and directed to arrest the said Benjamin Shockley without delay and have him before us forthwith that he may be dealt with according to Law and for his so doing this shall be his Justification. — Given in Council this 15th Day of February 1701. —

Whereas from the Information we have received there is just Reason to suspect a certain Captain Beach now in Jail in Hartford County of clandestinely trading with the Enemy and transporting Flour to New York. The Lieutenants of Jail and Hartford Counties are hereby empowered, required and directed to arrest the said Capt Beach and have him before us forthwith that he may be dealt with according to Law and for their so doing this shall be their Justification. Given in Council this 15th Day of February 1701. —

Friday 16th February 1701.

Ordered that the western shore Treasurer pay to Robert Miles four pounds, four shillings and four pence half penny of the new Emission in lieu of one hundred and fifty eight pounds fifteen shillings due him paid passed by the Act

That the said Treasurer pay to Jeremiah Townly Esquire Seventy five pounds of the same Emission in full for his last year Salary —

That the Commissary of Stores deliver to Serjt John Steary of the 5th Regimt. one Gilt and one pair of Woollen overalls —

Ordered that the western shore Treasurer pay to Charlotte Small five pounds of the new Emission in lieu of two hundred pounds due her per Account passed by the Dept Auditor. —
