

Thursday 29<sup>th</sup> March 1781.

Ordered that the western shore Treasurer pay to John Blamore fifty Dollars of the New Emision on Account —

That the said Treasurer pay to Daniel of St Thomas Dealer Esq: one hundred and eight two pounds ten shillings of the same Emision in lieu of fifty five pounds specie for one Horse Job lot to Liev Cooper as per Certificate of Wm. and John Ballen and also the further sum of three hundred and thirty five Dollars of the same Emision due him per Account paid by the Adm' G'd.

That the said Treasurer pay to Rachel Washington one hundred and seven pounds of the same Emision to be delivered over to John Ballen on Ac't.

That the said Treasurer pay to Capt Gilbert Middleton thirty seven pounds ten shillings of the same Emision to be delivered over to Captain William Middleton on Account. —

That the said Treasurer pay to Robert John Smith one hundred and eighty two pounds eight shillings and nine pence of the same Emision due him per Account paid by the Adm' G'd. —

That the said Treasurer pay to Capt. Gilbert Middleton twenty two pounds ten shillings of the same Emision on Account.

That the said Treasurer pay to Col John Dorsey sixty one pounds five shillings and two pence of the same Emision for the use of Capt Richard Dorsey of the Artillery due him per Account paid by the Adm' G'd. —

That the said Treasurer pay to Capt Alexander Howard & Haguder eighty four pounds seven shillings of the same Emision for the use of William & Haguder due him per Account paid by the Adm' G'd. —

That the said Treasurer pay to John Dine Esq: one hundred and twenty four pounds seven shillings and ten pence fifty pounds and nine pounds nineteen shillings and eight pence of the same Emision due him in full for his salary last year as Commissary. —

That the said Treasurer pay to Capt Richard Dorsey of the Maryland Artillery twelve pounds six shillings and two pence of the same Emision due him for Stores per Account paid by the Adm' G'd. —

That the said Treasurer pay to Capt James Charles Smith, Rachel Burges, Lieut John Plant Ensign James Buckham and Theodore Middleton of the late Detar. Regiment, each Fifty pounds of the New Emision in lieu of twenty pounds specie as part of their account paid by the Auditor General on Account. —
