Colo Samuel Smith of Baltimore, is appointed Agent to procure the necessary
for the Troops to be marched to the Southern Army. —

Friday 1. June 1781.

Ordered That the Spring Commissary deliver to Capt Alexander True-
man and Capt John Mitchell each, four Gallons of Rum and fifteen pounds
of Sugar due to the first Instant. —

That the western shore Treasurer pay to Captain John Mitchell
five pounds fifteen shillings and nine pence due him per Account passed by the D. Aud.
John Bullen is appointed Quarter Master in this State. —

Saturday 2. June 1781.

Ordered that the western shore Treasurer pay to Capt Thomas Mason
of the 7th Regimt, fourteen pounds nine shillings and four pence half penny due
him per Account passed by the Depty Aud. —

That the said Treasurer pay to Capt William D. Beall of the
6th Regimt Twenty three pounds three shillings due him per Ac^t passed by the Alf.

That the said Treasurer pay to Nicholas Mangus Thirty six
pounds, three shillings and nine pence due him per Ac^t passed by the Aud. Genl. —

That the Spring Commissary deliver to Capt Thomas Mason, ten
Gallons of Rum and forty pounds of sugar and also to Capt William D. Beall
sixteen Gallons of Rum and fifty four pounds of sugar due to the 1st Instant —

That John Bullen furnish Capt Gaither with a Horse,
Commission issued to Selby Parkers appointed Ensign of Capt
Bartlet Townsends Company in the Williams Battalion of Militia in
Worcester County. —

Monday 4. June 1781.

Ordered that the western shore Treasurer pay to Daniel Munro
forty Pounds, fifteen shillings due him per Account passed by the Depty Aud. —

That the said Treasurer pay to Samuel Smith Esq three hundred
and fourteen Pounds of Tobacco, such as will answer his purpose to be expended
in procuring Cloathing for the Troops of this State for which he is to be accountable.

That James Calhoun Esq. Commissary Genl. for the western
shore deliver to Samuel Smith Esq. two thousand five hundred Babels of
Merchantable Flou to be by him expended in procuring Cloathing as above ment^d. and

That Henry Hollingsworth Esq. Commissary General for the
Eastern shore deliver to Samuel Smith Esq. one thousand five hundred Babels
of Merchantable Flou to be expended as above directed and accounted for. —

That Colo Samuel Smith be requested to provide twenty Swords
and twenty Pistols for the Troop of light Horse raised in the County of Baltimore
County and that he furnish W. George Hepperts of Baltimore Town with
what Money may be necessary for making Ammunition Waggon, making
and repairing Carriages and cleaning and repairing Arms. —

That the Lieut of Frederick County immediately arm equip and
march five hundred Militia of his County, under proper Officers to George
Town in Montgomery County there to remain till his Board sheweth due.
