

Friday 8 June 1781.

Commission issued to William Shuckoff appointed Ensign of Capt
Henry Wheelers Company of Select Militia raised in Prince Georges County. -
Thomas Hall is hereby permitted to exhibit Theatrical Performances
Ordered that the Commissary of Stores deliver to Capt Gilbert Elliot -
as much Cannon as is necessary to alter the Ringtail and
become sufficient to make Alteration. -

Whereas it appears to this Board from the Representation of
John Barnes Esq that William Gibbons late of the State of Georgia was driven
from thence by the Enemy and has settled in this State, that he has taken the
Oath of Allegiance to the State of Georgia and done every thing that a good
Citizen could do in support of his Country - the said William Gibbons has the
Approbation of this Board to settle in this State. -

Robert Culver drafted from the Militia of Hartford County ap-
peared before the Board and having produced a Memorial from several of
the Inhabitants of the said County and a Certificate from Doct James
Murray of this City of his being incapable of Military Duty having had a
Fracture of his Leg near the Heel which has been improperly reduced, is
therefore discharged from the Service for which he was Drafted. -

Saturday 9 June 1781.

Ordered that the Commissary deliver to Lieut John
Gan of the 3^d Regim^t two Gallons of Rum and eight pounds of Sugar and also
to Capt Christian Brendoff of the 6th Regim^t thirty four Gallons of Rum and
one hundred and thirty six pounds of Sugar due to the 1st Instant.

That the Commissary of Stores deliver to Capt Christian
Brendoff Cloth and Trimmings for a Suit of Cloaths and Linnen for four
Shirts due him for the Year 1780. -

Commission issued to Matthew Ridley Esq appointed Adju-
tant to the Troops of Light Horse raised in this State and now ordered into
actual Service. -

Mr Lyde Goodwin is hereby appointed Surgeon and William
King Quarter Master of the Troops of Horse raised in this State and now
ordered into actual Service. -

Whereas from Information given this Board have good reason to
believe that Henry Newcomer and Bleachy of Washington County and Fritchey
Kelly and Finckles of Frederick County are disaffected and Dangerous Persons
whose going at Large may be detrimental to the State - The Lieutenant of
Washington is therefore ordered to arrest Henry Newcomer and Bleachy and the
Lieutenant of Frederick to arrest Fritchey Kelly and Finckles without delay and
have them before the Board forthwith that they may be dealt with according to Law. -

Monday 11 June 1781.

Ordered that the Commissary of Stores deliver to Capt John Mitchell
as much Linnen proper for binding Soldiers Hats as he may think necessary -

That the Collector of the Tax for St Marys County pay to Joseph Ford Com^r
for said County fifteen thousand pounds of Tobacco on Acc^t. -
