That the said Treasurer pay to John Brue Esq. ten pounds ten shillings of the same Emission of the money appropriated as aforesaid due him per Account passed by the Auditor General. -

That the said Treasurer pay to John Miller fifty nine pounds seven shillings of the same Emission of the money appropriated as aforesaid due him per Account passed by the Aud. Genl. -

That the said Treasurer pay to Capt James Woolford Gray of the 3^d Regmt. fifteen pounds of the same Emission of the money appropriated as aforesaid for Stores on Account. -
