

Saturday 13th July 1782

Ordered that the western Shore Treasurer pay to Capt. Duffin two Pounds, twelve Shillings and six Pence of the Bills emitted under the Act for the Emission of Bills of Credit *per* due him *per* Act *passed* -

That the said Treasurer pay to Joseph Dowson Sixty Pounds eight Shillings and three Pence of the same Emission, thirty Pounds eleven Shillings for his own use & twenty nine Pounds sixteen Shillings & seven pence to be paid over to Nicholas Valiant due them on Certificates issued by Henry Hollingsworth D. L. & G. adjusted -

Commission of Letters of Marque & Reprisal issued to Thomas Moore Commander of the Ship York two hundred and seventy eight Tons burthen, navigated by forty one Men, mounting ten Cannage Guns belonging to John & M^r Laro & Hugh Young of Baltimore. -

Monday 15th July 1782

Ordered that the western Shore Treasurer pay to John Brewer fifteen Pounds ten Shillings of the Bills emitted under the Act for the Emission of Bills of Credit *per* to be delivered over as follows, four Pounds to John Goldsmith - four Pounds to John Blackiston - three Pounds to Thomas Howard - two Pounds to John Gardner and ten Shillings to Thomas Gardner the Bounty allowed for manufacturing Salt *per* Account *passed*.

That the said Treasurer pay to Samuel Baldwin ten Pounds, ten Shillings of the same Emission due him *per* Account *passed* -

That the said Treasurer pay to William Para seventy eight Pounds, six Shillings & three pence *per* due agreeable to the Act to the Act to adjust the Debt due from this State *per* Account *passed* 13th Instant -

Commission of Letters of Marque & Reprisal issued to John Anig Commander of the Schooner Resolution fifty five Tons burthen navigated by twelve men mounting six Cannage Guns belonging to Samuel Yerock & others of Baltimore. -

Tuesday 16th July 1782

Ordered that the western Shore Treasurer pay to Francis Deakers Esq^r two hundred and twenty nine Pounds, ten Shillings & ten Pence - & Joseph Duwall three Pounds, twelve Shillings and six pence of the Bills emitted under the Act for the Emission of Bills of Credit *per* due them *per* Account *passed* -

That the said Treasurer pay to Samuel Davidson twenty seven Pounds, five Shillings of the same Emission to be delivered to Henry Lowe due him *per* Account *passed* -

That the said Treasurer pay to John Evans ten Pounds, one Shilling and five Pence of the same Emission for the use of himself & Thomas Collins *per* Certificate issued by Henry Hollingsworth & William & M^r Brydo adjusted & *passed* -

That the said Treasurer pay to William Wilkins forty one thousand nine hundred & fourteen pounds of Tobacco including four *per* Cent for Cash in lieu of three hundred & fourteen Pounds, seven Shillings & two pence part of an Order on the Treasury of the 5th Inst. for three hundred & sixty four pounds
