from this State" and dated the 26 day of July 1781.

That the said Treasurer pay to the said James Langole for the
use of Nicholas Maubbin One hundred and sixty three pounds, two shillings and
four pence half penny for one Year's Interest due him the 25 July 1783 on the
abovementioned certificates.

That the said Treasurer pay to Thomas Jones Esquire One hundred
and fifty Pounds Current Money Balance of Salary as one of the Judges of the Court
of Appeals to October Court 1783 per Account passed by the Auditor General.

Month per Account passed by the Auditor General.
