That the said Treasurer issue a Certificate to William Adams Esq^r agreeably to the Act aforesaid for Two hundred and fifty two pounds ten shillings and four pence due on Continental Loan Office Certificates adjusted by the Auditor General the 15th November last

That the said Treasurer issue a Certificate to Thomas Ogle agreeably to the Act aforesaid for Twenty three pounds, sixteen shillings due on Continental Loan Office Certificates adjusted by the Aud^r General the 1st Instant. -

That the said Treasurer pay to Roger Brooks one pound two shillings and nine pence farthing current money due him for Interest to the 6th Sept 1782 on a Certificate issued under the "Act to adjust the Debts due from this State" 6th Sept 1781 and numbered 181.

That the said Treasurer pay to Roger Brooks one pound, two shillings and nine pence farthing current money due for Interest to the 6th Sept. 1783 on the above mentioned Certificate. -

That the said Treasurer pay to Col^l James Kent Twelve pounds eight shillings and ten pence half penny current money due him for Interest for one year to the 5th October 1783 on a Certificate number 223 issued under the "Act to adjust the Debts due from this State" 7th January 1783. -

That the said Treasurer pay to Joseph Richardson Three hundred and fifty seven pounds, six shillings and four pence three farthings specie agreeably to the "Act to adjust the Debts due from this State" due on five state Certificates adjusted by the Auditor General the 29th November last
