

Wednesday 21<sup>th</sup> February 1787

The Council met

Present as on yesterday.

Ordered That the western shore Treasurer pay to John Wright Three pounds, fifteen shillings on account of salary due him as Clerk to the Commissioners of Accounts to the 1<sup>st</sup> instant

That the said Treasurer pay to Frederick Green Ninety three pounds, fifteen shillings for one quarters salary as Printer to the State due him the 1<sup>st</sup> instant
