

Thursday November the 20 1806

The Council met Present His Excellency the Governor and all the Council.

Ordered that the Treasurer of the Western Shore pay to Captain Robert Derry the sum of Twenty five pounds for one quarters Salary as audited General due the first instant.

Ordered that the said Treasurer pay to Frederick Green Liquor two hundred and twenty five pounds for half years Salary as Paid to the State due the first instant.

Ordered by the Governor that the Treasurer of the Western Shore pay to Lieutenant Shadysen the sum of fifteen pounds for one quarters half pay due as above.

Ordered by the Governor that the Treasurer of the Western Shore pay to Captain Percy Benson twenty two pounds ten shillings for one quarters half pay due as above.

Ordered by the Governor that the Treasurer of the Western Shore pay to Mr. Joseph Dawson three pounds fifteen shillings for one quarters half pay due as above.

Ordered that the Treasurer of the Western Shore pay to Richard Tighman Esq; the sum of forty one pounds two shillings and three pence for Salary due as a Member of the Council the first instant.

Ordered that the Treasurer of the Western Shore pay to Samuel Green Esq; Deputy Post Master fifty nine pounds three shillings and two pence for Postage for the Governor, Auditor and Treasurer as per account paid by the auditor.

By the Petition of Adam Bonn late Sheriff of Prince Georges County accompanied by a Transcript from the Proceedings of the Court of the said County it appears that at September term eighteen hundred and three a judgment was found against a certain Alexander Harvey for selling liquor without license - That a Writ issued against the said Harvey returnable to April term eighteen hundred and four - That at September term eighteen hundred and five an amendment for six pounds was finally closed against the Petitioner for not producing the said Harvey - The Petitioner states that he was unable to do so, as the said Harvey during the sitting of the Court at April term eighteen hundred and five was committed to jail upon a charge of House Thaling, and that during the sitting of the said Court he broke jail and made his escape. The Petitioner further states that he made every exertion to locate the said Harvey but without effect. The Board on consideration of which circumstances and from the recommendation of the Court of the said County do remit the said for forfeiture.

By the Petition of Ann Greenwell of Prince Georges County accompanied by a Transcript from the Proceedings of the Court of the said County it appears that she was presented at September term last in several instances for selling Spirituous Liquors without license and was fined the sum of six pounds in each case amounting in the whole to the sum of thirty six pounds. The Petitioner states that her late husband Justus Greenwell did for many years before his death keep an ordinary in Prince Georges County and regularly obtained a license for that purpose. That since the death of her husband she has found it necessary to continue the same business in order to support herself and family. That in the Fall of the year eighteen hundred and five she contracted with a Mr. Hartbine for the rent of his House at the Big Spring in Washington County where she intended to remove in a few weeks. That owing to that circumstance she omitted to take out a license at September Court eighteen hundred and five which would have cost the Petitioner six pounds for shillings and which in case of her removing (as she fully expected) would have been of no service to her in Washington County and which could not have been transferred to any other person. The Petitioner further states that contrary to her expectation Mr. Hartbine
