Ordered that the Treasurer of the Western Shore pay to Captain James Walker acting Major in the 45th Regiment twenty one Dollars and thirteen cents pay due him for services in Saint Marys County in May 1800 as per account papered and filed.

The Council met. Present His Excellency the Governor and the Honourable William H. Wood Samuel Ridout and Alexander Conlee Magruder.

Littleton Gale, John Conway, Job Haynes, Daniel Job of Daniel, Thomas Richards, Thomas Reynolds, James Pagan Senior, Nathaniel Oldham, Nicholas Hayland of Stephen, Jacob Hyland of Jacob, Thomas May, Lewis Miller and Matthias Tyson were appointed Justices of the Peace for Cecil County and a new Commission issued to the said County including them.

Jonathan Greenwood was appointed Notary Public for Cecil County to reside at Frederick Town and Commission issued to him accordingly.

George Kidd was appointed Notary Public for Cecil County to reside at Port Deposit and Commission issued to him accordingly.

Ordered that the Treasurer of the Western Shore pay to Joseph Morris Paymaster to the 25th Regiment fifteen Dollars for his pay while in service in May last as per account papered and filed.

Ordered that the Treasurers of the Western Shore pay to Benjamin Fenwick a private in Capt. M. Gausins Company of Cavalry six Dollars and sixty three cents the amount of his pay for services in July last omitted to be inserted in the roll.

Ordered that the Treasurer of the Western Shore pay to John Wilkins eighteen Dollars for cleaning Muskets bayonets &c per order of Major H. J. Caswell as per account papered and filed.
