His Excellency the Governor attended this day.

The following Orders were issued by His Excellency the Governor upon the demand and information and evidence therein mentioned.

The State of Maryland, To the Sheriff of Frederick County
 greeting. Whereas it appears from authentic documents, certified and transmitted
 to the Executive Department of this State by His Excellency George Wolf Governor
 of the State of Pennsylvania, that a certain Daniel Schaeffer stands charged
 in that State with having committed in the County of Lancaster in the Commonwealth
 of Pennsylvania the crime of Murder and that the said Daniel Schaeffer
 has fled from the Justice of the said State and is now in custody in the County
 of Frederick in this State. And whereas the said George Wolf Governor
 of the said State of Pennsylvania in pursuance of the authority given in such case by the
 Constitution and laws of the United States demanded the said Daniel Schaeffer
 of the Executive of this State as a fugitive from Justice and appointed Adam
 Baird Esquire his agent to receive the said fugitive and transport him to
 the said State of Pennsylvania for trial for the said offence. Now
 therefore the said George Wolf Governor of the State of Maryland have
 thought proper in compliance with the said demand to order and direct
 the Sheriffs of this State and fugitives, and I do hereby order and direct that
 you forthwith deliver the said Daniel Schaeffer if he is in your
 custody or within your bailiwick to the said Adam Baird Esquire agent
 as aforesaid, he the said agent first paying all costs of the arrest and
 detention of the said fugitive. In all which things shall be your sufficient
 Warrant. Given under my hand and the Great Seal of the State of
 Maryland this twenty fourth day of September in the year
 of our Lord one thousand eight hundred and thirty one, and
 of the Independence of the United States the fifty sixth.

 to the Executive Department of this State that the said Daniel Schaeffer
 stands charged by affidavit with having committed in the County of Lancaster
 in the Commonwealth of Pennsylvania the crime of Murder, and having fled
 from Justice and taken refuge in this State, and it is believed a now in custody in
 the County of Frederick in this State, therefore the said George Howard Governor
 of this State of Maryland do hereby require and enjoin all persons within
