

The State of Maryland, do hereby certify that
Whereas it appears from authentic documents, certified and transmitted to the
Department of this State, by His Excellency George Wolf Governor of the State of
Pennsylvania, that a certain William Dorsey late of the County of York, in the
-wealth of Pennsylvania, stands charged by Indictment of the grand Jury of the
Court of Oyer & Terminer and Jail delivery of the said County of York, with having,
on the twentieth day of December last, committed in the said County the crime of
Horse Stealing, and that the said William Dorsey has fled from the Justice of
said State and is now confined in the Jail of Harford County, in this State.

And whereas the said George Wolf Governor as aforesaid hath, in pursuance
of the authority given in such cases by the Constitution and Laws of the United
States, demanded the said William Dorsey of the Executive of this State, as a
fugitive from Justice, and appointed Adam Eichelberger Justice Sheriff of the said
County of York, his agent to receive the said fugitive and transport him to the said
State of Pennsylvania, for trial for the said offense. Now therefore, I, James
Thomas Governor of the State of Maryland, have thought it proper in compliance
with the said demand, to order and direct the Surrender of the said fugitive,
and do hereby order and direct that you forthwith Surrender and deliver
the said William Dorsey, if he is in your custody as aforesaid to the said
Adam Eichelberger, agent as aforesaid; he the said agent for the paying the
costs of the arrest and detention of the said fugitive — for all which this
shall be your sufficient warrant.

Whereas, in compliance with and
Demand of His Excellency George Wolf Governor of the State of
Pennsylvania, orders have been given for the Surrender of a certain

-uments transmitted to the Executive Department of this State that

-wealth of Pennsylvania, with having, on the twentieth day of December
last committed in the said County the crime of Horse Stealing;
Therefore, I, James Thomas, Governor of the State of Maryland, do
renew and enjoin all persons within this State to let said
agent as aforesaid, pass with the said fugitive to the
