

May 24th 1842.

This day remitted a fine of ten dollars imposed upon Patrick McGee by Allegany County Court for selling liquor without a license

27th

This day remitted (with the exception of five dollars) the fine imposed upon Richard S. Peck, of \$33.33 1/3 by Lucas Ann County Court for selling liquors to negroes after night without an order.

30th May 1842.

This day appointed Mr. Edward P. LeCompt Clerk of Rochester County Court.

June 2nd 1842

This day remitted a fine of \$500 imposed upon Valentine Carter by Anne - Arundel County Court for keeping a Faro-Table.

June 3rd 1842

This day directed the Sheriff of Harford County, Maryland, to deliver to Gustavus A. McCartney, Thomas D. Temple, alias Miller, for in compliance with a requisition by the Governor of Pennsylvania on the Governor of Maryland.

June 10th 1842

This day pardoned Moses Anderson, (a free Negro) of Harford County who was convicted of having stolen a small amount of property belonging to a certain William Buckingham of Harford County, said Anderson having been recommended to Executive clemency by the Judge, Jury and others, the said pardon in these words: (see Pardon-book)

June 24th 1842

This day sent to the clerks of the several County Courts the laws and public documents agreeably to the following statement.
