before Our Trusty and well beloved Colonel William Hooper and others Justices of an Especial Court
of Oyer and Terminer and Goal delivery for Queen Anns County afo. Nevertheless We grant
unto him Our firm Peace and will not that he suffer any Corporal Punishment therefor
Provided that he the said Absalom Scott shall within ten days from the time of his Delivery
out of goal Transport Himself or cause Himself to be transported out of this Our Province
and never to return again otherwise this Our Pardon shall be and is hereby declared to be
Void and of no Effect anything herein contained to the contrary Notwithstanding - Witness
Our Trusty and well beloved Robert Eden Esq. Governor and Commander in Chief in and
over Our said Province this sixteenth day of April in the Nineteenth Year of his Lordship's
Dominion Anno Domini 1770 -
