

or from our said Navale Officers or any other Persons on all or any of the aforesaid Branches of our Revenues and upon Receipt of any Money Bills of Exchange or other Effects sufficient discharges and acquittances to give and Sign to the Person and Persons concerned or owing such Money Effects and Bills of Exchange and generally to act do perform fulfil and accomplish according to the Instructions which have been or may be given him by us the said John Moore Hugh Hamersley and Peter Prevost all and every other Act and Acts Thing and Things requisite and necessary for the due Execution performance and justly discharging the severall and respective Offices Powers and Authorities hereby given or granted him or intended to be given and granted to him And We do hereby Satisfy Confirm and hold for good effectual and valid whatsoever the said Daniel of Saint Thomas Senifer shall lawfully do or cause to be done in the Premises notwithstanding any insufficiency or defect in the Words Expressions Clauses or Sentences of this our Commission and although every particular matter strictly requisite be not herein strictly expressed And We do further for a Compensation Salary and Encouragement to the said Daniel of Saint Thomas Senifer for the punctual sincere and faithful performance of the Powers and Authorities hereby granted him and in consideration of the Pains Labour and Trouble he shall take in the due Execution thereof Authorize direct and empower him to take receive and retain to and for his own use out of all such Monies Tobacco or other Effects as shall be received on any of the Accounts aforesaid arising from our said Land Office or from our Manor and other Rents and Fines and all other our Property to be collected by him the said sum of Five hundred Pounds lawfull Money of Great Britain per Annum or as proportionable part of the said sum according to the time of his holding and exercising the said Office of Chief Agent Collector and Receiver General aforesaid as a full recompence for and in satisfaction and discharge of all Commissions Salary and other Fees and Rewards whatsoever for such his Lane and Pains in the Premises and all Services relating thereto Provided always and it is the true Intent and meaning of these Presents notwithstanding any thing herein before contained that the said Daniel of Saint Thomas Senifer shall from time to time and at all times obey execute and perform all such Rules and Orders for his conduct in the Premises as he shall receive from us the said John Moore Hugh Hamersley and Peter Prevost our Lieutenant Governor or Board of Officers appointed or to be appointed by us And this our Commission and the Powers herein granted are to continue during our Pleasure
