conceive, will be useful & therefore would not have you purchase it.  
If we find it absolutely necessary, we shall give the Power of seizing, but  
is the Intention of the Act, that the Measure should not be taken, but on  
the most pressing Occasion. If you can contract from £9-10- to £11-0-  
for Wheat, and £17-10- to £18-15- for good Flour, we think, you had  
better go on, you shall be very soon furnished with Money. You must  
hire Carriages to transport the Provisions; if not to be hired, on Informa-  
tion given us, we shall send an Order to have them impressed  
Col<sup>o</sup> Isaac Perkins. We are &c.

520 Sir. The Persons Appointed in consequence of the late Act of Assembly of this  
State to purchase Wheat, Flour, and Bread for the Use of the Continental  
Army, are in Want of Money to proceed in the Business. We are advised  
that about 10,000 Barrels are wanted; our Treasury is by no Means able  
to advance the Money; if the Quantity is procured, it will not cost  
much, if any Thing less than £500,000. We have lately advanced about  
30,000 Dollars for the Recruiting Service. We request that Congress will  
furnish us, through the Hands of our Delegates, with as great a Part  
of these Monies as can be immediately issued and the Residue as  
soon as at all convenient; the Purchasers already have a Demand  
on us for upwards of 100,000 £ and any Delay may produce very  
disagreeable consequences - We have the Honor to be &c.  
President of Congress.
