Be it further enacted & Ordained by the authority aforesd by &  
with y<sup>e</sup> advice & assent aforesd, that, from & after y<sup>e</sup> end of this present  
Session of Assembly, noe Sheriffe, Sub Shiffe or Depty Shiffe of any  
County, or Clerk, Sub-Clerk or Depty Clerk of any County Court, or  
other person that hath any thing to doo whatsoever with the Records of the  
said County Courts, shall (in the said County Court where he is Shiffe, Sub Shiffe or  
Depty Shiffe, Clerk, Sub Clerk or Depty Clerk, or hath any thing to doo  
with y<sup>e</sup> Records, as aforesd) plead as an Attourney within the said County  
within this Province, for any person whatsoever, that for every such  
cause he shall so plead in the said County Court within this Province, of  
whch County he is Sheriffe, Sub shiff or Dep. shiff, or of wch Court he is  
Clerk, Sub Clerk or Dep. Clerk, or hath any thing to doo with y<sup>e</sup> records of  
y<sup>e</sup> said Court, he shall forfeit, for every such offence, the sume of 2000<sup>l</sup> to be  
two 3<sup>d</sup> parts thereof to be forfeited to the L<sup>d</sup> Prop<sup>y</sup>. to be disposed on  
to the defraying the Charge of Wolbe<sup>r</sup> roads & the poor of the County  
wherom y<sup>e</sup> offence shall be committed, by the order, & at the discretion of  
the Com<sup>rs</sup> of such County from time to time, or the major part of them,  
the other third part to y<sup>e</sup> Informer, or him or them that shall sue for  
the same, the said fine to be recovered in any Court of Record within  
this Province, by Bill, Plaint or information, whom no assigne,  
protection or wagon of Law to be allowed.

## An act for killing of Wolves.

Be it enacted by y<sup>e</sup> R<sup>t</sup> hon<sup>ble</sup> y<sup>e</sup> L<sup>d</sup> Prop<sup>y</sup> by & with y<sup>e</sup> advice  
& consent of this present gen<sup>l</sup> Assembly, that every person who shall  
bring the head of a Wolfe to any of y<sup>e</sup> Com<sup>rs</sup> or Justices of the  
peace in any County of this Province, shall be allowed two hundred  
pounds of tobac from the County where the wolfe shall be killed; and  
that such Com<sup>rs</sup>, or Justice of the peace to whom the Wolfe's head  
shall be brought, shall rutt or cause to be cutt out the tongue, and  
cutt or cause to be cutt off the eares of the said Wolfe's head,  
to prevent the deceit of twice or after paying for the same. This  
Act to continue for three yeares, or to the end of the next Session  
of Assembly wch shall first happen. And

Be it further enacted that all other Acts formerly made  
for the killing of Wolves, be & are hereby repealed
