of the said Jacoby Ester to the said two Houses of Assembly.

## A Supplementary act to the act for limitation of officers fees.

Be it enacted by the Right Honourable the King & Queen with  
the advice & consent of the upper & lower houses of this present  
Assembly & the authority of the same that no Justice within this  
Province shall take demand part or part of any person or persons  
whatsoever, for any arrest or attendance upon any person or persons  
being in his custody out house less than four & twenty hours, above  
the sum of thirty five p<sup>ts</sup> of Tob. under the penalty contained in  
the act for limitation of officers fees, made at a session of Assembly  
begun the fifteenth day of May one thousand six hundred & seventy  
& six & for the future not of officers or officers in the said act particularly  
mentioned nor any the County Sheriffs within this Province (whose  
fees are by an act of Assembly begun the twentieth day of October  
one thousand six hundred & seventy & eight limited & settled) shall  
by virtue of either of the said Acts levied or cause to be levied any  
detention upon the body goods or chattels of any person or persons what-  
soever, for any fees in the said several Acts limited & contained  
without first delivring or caused to be delivred at and a just amount  
of the fees to them due by the acts aforesaid underhand or under  
of such officers or officers as aforesaid, to the person or persons from whom  
such fees demands are due as aforesaid, & if any officer or officers in  
either of the said Acts named shall exact charge demand or receive  
any fees for any matter or thing Toppay or Toppay, where the person  
or persons concerned, never required had or received the same or shall  
doe any matter or thing directly or indirectly contrary to the true intent  
& meaning of the said several Acts shall lose & forfeit the several  
penalties in the said several Acts to be such & forfeited in such manner  
as in the said several Acts is set forth & declared. Provided that this act  
nor any thing therein contained shall not be construed taken or adjudged  
to debar or hinder any person or persons whatsoever from prosecuting any  
action already commenced or hereafter to be commenced for breach  
of either of the said Acts, the recovery of the penalties already incurred  
by any thing therein contained to the contrary notwithstanding. Provided  
also that no suit or action hereafter to be commenced for breach of  
this present act or either of the aforesaid Acts shall be commenced prosecuted  
or sued after two years after the end of this present session of Assembly or  
after two years after the cause of action.
