

County Courts & the sd Maj<sup>r</sup> Recorder & Aldermen of the sd City be & are  
 further empowered & authorized at their severall County Courts & the  
 Court in the Month of Janu<sup>r</sup> next & in every ensuing year during  
 the continuance of this act in the sd month of Janu<sup>r</sup> having summons  
 every Respective Ordinary Keeper within their Respective Counties  
 & City thence thier to appere before them to sett Assess Rates and  
 Prizes of all Liquors whatsoever (not heretofore within this act inclosed) by  
 them the sd Ordinary Keepers vendid or to be vendid for 6 years ensuing  
 & for every year ensuing the continuance of this Act as aforesaid  
 with sd Rates & Prizes so to be sett Assesid Limited & appointed by  
 Com<sup>rs</sup> aforesaid & by the Magistrats of the City aforesaid shall be by their  
 severall Respective Clerks fairly Transcribed & sett up at their severall  
 Respective County Courts & City aforesaid in some Publicke place or  
 Places there if any person or persons may see & give the same for which  
 Juniors & Table Prizes every Ordinary Keeper shall pay to such Clerk  
 the sume of forty pounds of Tobb & any Ordinary Keeper or Junitor  
 that shall after setting & Assesing the Rates & Prizes aforesaid directly  
 or Indirectly presume to take Exact demand & Receive for 6 Prizes  
 pay for any such Liquors for with the sd Rates & Prizes shall be sett  
 Assesid as aforesaid of any person or persons whatsoever above 6 Rates and  
 Prizes so to be sett & Assesid as aforesaid shall for every such default for  
 feitt & pay into 2<sup>d</sup> Hon<sup>rs</sup> the 2<sup>d</sup> Prop<sup>r</sup> the sume of five hundred pound  
 of Tobb One halfe thereof to his sd 2<sup>d</sup> Prop<sup>r</sup> & the other halfe to him or them that  
 shall Informe & sue for the same & loose every such debt so unjustly charged  
 Exacted & demanded, the sd forfeitures to be Recovered in any Court of Record  
 within this Province, where no Exosome Protection or wager of Law to be  
 Allowed & every such Ordinary Keeper if shall demand exact or Receive above  
 the sume of Ten pounds of Tobb for small Boore Twenty pounds of Tobb  
 for stronge Boore for a Night Lodging in a bedd four pound of Tobb for  
 a Peck of Indian sheld Corne or Oats for a horse Twelve pound of Tobb  
 for Pasture for a horse a night six pound of Tobb for Hay or straw for a  
 horse a night ten pound of Tobb shall also pay & forfeit for every such  
 default to the 2<sup>d</sup> Prop<sup>r</sup> the like sume of five hundred pound of Tobb One  
 halfe thereof to his sd 2<sup>d</sup> Prop<sup>r</sup> & the other halfe to him or them if shall Informe  
 & sue for the same & loose his debt so unjustly charged as aforesaid the  
 forfeitures to be Recovered in any Court of Record in this Province  
 where no Exosome Protection or wager of Law to be allowed. All  
 to Content that all persons Inhabitants Travellers & Strangers as they  
 may be containe of sufficient accomodations for themselves & horses  
 it Enacted by 6 Authority aforesaid of every Ordinary Keeper or Jun  
 itor so to be Licenced as aforesaid shall within six months after granting  
 their Respective Licences be & are hereby Obliged to provide & maintain  
 Accomodation of Oats Hay & straw for Linding Indian Corne together  
 with stable Room convenient & sufficient for twenty horses at the  
 least, under the Penalty of the forfeiture of paying the sume of Ten  
 Thousand pound of Tobb One halfe to 2<sup>d</sup> Prop<sup>r</sup> the other halfe to the  
 Informer or him or them if shall sue for the same to be Recovered by  
 bill Plaint or Informacion in wch no Exosome Protection or Wager of Law  
 to be allowed, Provided always if no person or persons so Licenced or to be Licenced
