

Court, as also all Costs & Damages if shall be awarded by the Superior Court where
 such Writ of Error are Returnable: and as it further Enacted by the
 Authority aforesaid of all every Appeals made in manner aforesaid shall from
 henceforth by the Provincial Court of this Province be admitted & allowed of in
 Nature of a Writ of Error: and as it further enacted by the Authority
 aforesaid of all every Clerk & Clerks of the respective County Courts or
 other Inferior Courts of Record of this Province shall be & is hereby
 Obliged (at the time of such Courts sitting when any Appeals shall be
 demanded) to enter a Bill of Amount of the same Demand as well in his
 or their Journal as in the true Record of the Proceedings of such Court
 or Courts & if no Clerk or Clerks of any County Court or other Inferior
 Court of Record of this Province shall for the future Refuse or delay upon
 Request of any such Appellant to write or make out Transcript or Tran-
 =cripts of such Proceedings as aforesaid with his hand & seal of the Court as
 aforesaid upon Penalty to pay the respective Damage & Damages with such
 person or persons shall justly come, by such Refusal or delay as aforesaid the said
 Appellant paying & answering such respective Clerk his just Fees
 for the same according to Law: AND as it further enacted by the Authority
 aforesaid of the Act Entituled an Act to prevent Unnecessary delay of
 Executions made at a Genl. Assembly held for this Province & first on the
 day of May One Thousand six hundred seventy & six & every of them
 be from henceforth wholly Repealed AND lastly be it Enacted by the
 Authority aforesaid if no Officer or Officers within this Province shall
 hereafter for any Writ of Error, Supplicias or fieri facias to leave
 Judgment upon Error from the Provincial Court of this Province to any Court
 or other Inferior Court of this Province, Receive or Demand any
 more or other Fee or Fees than is hereafter mentioned (if it is to say) for a
 writ of Error to the Socy fifty pounds of Tolls & to the Chancellor for the
 Seale thereof One hundred & twenty pounds of Tolls for a Supplicias
 to the Socy fifty pounds of Tolls & to the Chancellor for the Seale thereof
 One hundred & twenty pounds of Tolls. for a fieri facias to the Socy fifty
 pounds of Tolls & to the Chancellor One hundred & twenty pounds of Tolls
 for the Seale thereof & no more, any Act heretofore made or any Law
 usage or Custome to the contrary in anywise notwithstanding this Act
 to continue for three years or to the end of the next Genl. Assembly which
 shall first happen.

An Act for Limiting the County Clerks Fees in
 this Province.

It is Enacted by the Rth Hon^{ble} & P^{ty} Prop^{ty} willing & desiring to ease & comfort
 of his good People in suits at Law did at the first session of this Assembly
 by the advice & consent of the Upper & Lower Houses of Assembly by
 Act Entituled an Act for the ease of the Inhabitants of this Province
 in suits at Law for small Debts & that a Sum of fifteen hundred pounds of Tolls
 should be paid in the County Court
 by means whereof Multiplicity of suits & Actions are moved & stirred
 the said County Court to the great profits of the Clerks thereof in their
 and
