 yet notwithstanding the County Court Clerks by Colours of the said Act those
 fees have not as yet been otherwise settled do presume to take same fees
 for such things as do relate to their respective Offices as are limited to the
 said to the great grievance of many poor suitors in the County Courts
 of which many Complainants have been made to the Delegates of the Lower House
 of Assembly for the removal thereof for the future and for determining
 the County Clerks fees & Delegates of this present Year Assembly do
 pray if it may be enacted & be it enacted by the Honorable the Delegates
 of the Advice & Consent of the Upper & Lower Houses of this present Year
 Assembly & Authority of the same if from henceforth the Clerks in any
 County Courts within this Province shall demand take exact or receive
 of any suitor Plaintiff or Defendant or other suitor or Petitioner any other fees
 than are hereby limited & directed. (1724)

Provided always if in case any person shall refuse to pay the same so by this
 Act limited & allowed it may be lawful for every County Clerk within
 this Province to recover the same by way of Execution against the goods or body
 of the person so refusing & no other. And if the County Court Clerks or any of
 them shall do contrary directly or indirectly to this Act he or they shall be
 liable to the penalties therein expressed & shall also forfeit & fine of three or
 five pounds of Tolls or twenty pounds first for every time he or they shall do
 contrary & one moiety to the Proprietors his heirs or successors & other Moynors
 the party bringing shall sue for same by any plaint action suite bill or difference
 in the Court of Sessions or any other Court of law shall be allowed Provided
 also if of any fees accrued for any matter or things hereafter to be done before
 any of the said Offices of Clerks in the County Court as aforesaid with this
 are not bound to do Ex Officio & by the Justices of the County Court as judges
 or otherwise
