Let the said Court or any five of them shall
 immediately without any formality of Law or forms here & determine
 Judgement according to their discretions
 And be it enacted by the authority aforesaid of the said Court shall have and
 receive for purchasing such Lots of five Lott being marked & staked out
 as aforesaid the sum of thirty pounds of Tobacco Lott to be paid by him
 or them who shall take up the said Lott or Lotts.
 And in case the taker up of the said Lott or Lotts refuse or neglect to build
 the time appointed in this act that then it shall be lawful for any
 person or persons whatsoever to enter upon the said Lott or Lotts paying
 such sum of Tobacco as shall be first sett upon such Lott to the
 Court aforesaid of such respective County or such as under they
 shall appoint for the publick use & benefit of such Towne provided
 the person taker up or purchaser begin to build within one month
 after such his entry made, such house as in this act is limited and
 appointed, shall finish the same within six months next after
 such entry made as aforesaid, which house so built shall give & settle an
 Estate of Inheritance to him & his Heires forever in the precise building
 as aforesaid upon the said Lott or Lotts as aforesaid. In case any of the said Lotts shall
 be neglected to be taken up for edifying the same five years
 after the publishing of this act, if then in such case, the Owners &
 Persons interested shall be possessor of the said Lott or Lotts as in their
 first former Estate, any thing in this act contained to the contrary
 in any wise notwithstanding. Be it further enacted by authority
 aforesaid that all ships and Vessels trading into this Province after
 the said last day of August next shall be in the year of our Lord God One
 thousand six hundred eighty five, shall unlade & put on shore their
 severall & respective Goods & Merchandizes at such Townes Ports &
 places only as are in this Act before sett downe, & appointed to unlade
 Goods & Merchandizes at under the paine & penalty of losing and
 forfeiting all such goods & Merchandizes by them landed at any other
 places whatsoever, One third part thereof to the Lord Prop^r. One third part
 to the Justices of each respective County Court for the time being
 for the use and benefit of such Towne next adjacent in the County
 where the said Offence shall or may be committed, & One third part to the
 Informer or him or them if shall seize or sue for the same, in any
 of the Lord's Courts of Record within this Province, by bill Plaint or
 Information whereunto no Expense Protection or Wager of Law to be
 allowed.
 And be it enacted by the authority aforesaid that no Merchant Factor or
 Mariner or other person whatsoever trading into this Province, whether
 Foreigner or Inhabitant within this Province from and after the last
 day of August One thousand six hundred eighty five, shall traffick
 sell or barter away any goods or commodities within this Province,
 but at some of the Ports Townes & places here in this act before
 appointed, for the unlading goods & Merchandizes within this Pro-
 vince, under the paine & penalty of losing & forfeiting all such
 goods & Merchandizes sold or bartered away in any other place or
 places within this Province or the full value thereof to be given
 in any Court of Record within this Province, by action of debt
 bill plaint or Information One third part thereof to the Lord Prop^r.
