

Owner from the time of receiving the same, Casualties by fire or other un-
avoidable accidents andly excepted, in case any stockholder or other owner
and possessor of any such storehouse, leaving his storehouse empty or not
sufficiently filled nor having any occasion thereof for his own proper trade
or other goods shall wilfully refuse to receive take in, receive as
aforesaid, such tobacco so brought the said person refusing shall be liable
to pay unto the Owner of such tobacco all such damage, loss and
detriment as the Owner of such tobacco shall any way sustain by
reason of the refusal aforesaid the same to be recovered by Bill plaint
or Information whereunto no excuse pardon or waver of law to be allowed

And be it further enacted by the authority aforesaid of all parts due to
his Majesty the said Property of this Province his Heirs & Successors all public
Leavies & other Officers fees due upon Execution which shall become due
and payable from and after the 25 last day of August in the year of
our Lord One thousand six hundred Eighty & five shall be brought to the
Ports & places before mentioned and stored as other tobacco are
Provided that notwithstanding the said Property his Heirs & Successors
the Receivers of the Publick Levy, & the said Officers & their Heirs
shall allow pay or discount unto the said person or persons so bringing or
conveying the same to the said Ports & places, hereinafter mentioned the
full sum of five pounds of tobacco for every hundred pounds
of tobacco so brought & proportionally for a greater or lesser quantity

and be it further enacted by the authority aforesaid of what tobacco the
Sheriff or any other Receiver or Receivers shall accept Receive and
Collect at the said Towns ports & places hereinafter mentioned, which shall
grow due from and after the 25 last day of August in the year of
our Lord One thousand six hundred Eighty & five for his Majesty's Publick
Leavies, and Officers fees due upon Execution the said Sheriff
and Officers shall be allowed only the sum of five pounds of tobacco
for every hundred for receiving the same and proportionally for a greater
or lesser quantity any Lawe statute or usage to the contrary thereto
in any wise notwithstanding, provided the charge of storage of such
tobacco as shall be due as aforesaid to the Officers upon Execution shall
be allowed & discounted to the said stockholders by such Officers to whom
the said fees are due and payable.

and be it further enacted by the authority aforesaid of any person or
persons that shall build dwell & inhabit in any of the said Towns ports or places
hereinafter mentioned such person or persons shall & may contract
barter buy or purchase any quantity or quantities of goods or other
wares whatsoever any Lawe statute or usage to the contrary
notwithstanding Provided that persons buying the said goods
Merchandises shall likewise sell & barter away the said goods and
Merchandises in the same Towne, port or place where the same
were so bought or in any other Port or Towne within this Province
