

and be it further enacted by the authority aforesaid of and for the Tobacco
 which shall happen to be due ~~by~~ ^{by} many persons or persons whatsoever
 by the said last day of August One thousand six hundred Eighty five
 shall be brought to some one or other of the said Towne Ports or places
 within act limited and appointed, at the Charge of the Collector or collector
 such tobacco shall be due ~~and not otherwise~~.

and be it further enacted by the authority aforesaid of no person or persons
 not being Inhabitants & taxables within this Province shall at any time
 or times after the said last day of August One thousand six hundred
 Eighty five, Load transport, Carry away, in any boats or vessels
 whatsoever from any plantation ^{or} plantation ^{or} or from any other place
 or places save the towne or ports before mentioned to any port of the
 Province, or on board any ship or vessel whatsoever any tobacco goods
 wares or Merchandises of this Province with ^{the} personal and ^{the} loss of such
 tobacco goods wares and manufactures of this Province together with
 the loss of such sloop boats or other vessels ^{that} shall be transport
 or carry the same or the value thereof One third part to the Lord
 Proprietor One third part to the Justices of such respective County Court
 for the time being for the use & benefit of such next adjacent Towne
 or in the County where the offence shall or may be committed, and One
 third part to the Informer or him or them, if shall force or fines for the
 same to be recovered by action of Debt bill plaint or Informacion where
 use & some protection or warr of Lawe to be allowed.

and for encouragement of trade and quick dispatch of all shippes & vessels
 trading into this Province as aforesaid of there before year by his Lord
 Constituted and appointed in Vicecomore St. Marks, Parson and
 Annarrundell County Or the West side of this Province on the County
 of Talbot & Somerset on the Eastern side of this Province to take side
 entry & there all such shippes & vessels trading into this Province
 as aforesaid so if such shippes or shippes may not stand or be obliged to stop
 or stay for the same at any other port or place.

and further that the great number of towne ports places aforesaid
 may in time to come prove burthensome to the publick by increasing
 the number of Burgesses in assemblies. Be it enacted by authority
 aforesaid of no Towne port or place before mentioned shall at any time
 hereafter be enabled or made Capable of sending an Citizen or Citizens
 Burgess or Burgesss Delegate or Deputy to any Assembly hereafter to
 be convened or called until such time as the said Towne or towne, port or
 ports place or places shall be actually inhabited by such so many families
 as shall be sufficiently able to defray the Charge & expences of such Delegate
 or Deputy who shall be elected & chosen by the freemen of each respec=
 tive towne or the Major part of them without being in any sort Charge=
 able or burthensome to the respective County for or by reason
 thereof but if the Charge & expence of such Citizen Burgess Delegate
 or Deputy shall from time to time call times hereafter be defrayed
 born by the respective Inhabitants of such town port or place for
 whom they or any of them shall serve as aforesaid saving to the Citizens
 of the City of St. Marks all such Rights & priviledges as have been
 heretofore granted unto them by his Lord the Charter.
