

And whosoever shall be found guilty for refusing or neglecting to appear at the  
 not having a reasonable excuse for his absence to be allowed by the Commissioners  
 aforesaid or any five of them shall for every such default be fined two hundred  
 pounds of tobacco to be levied of his or their goods and chattels to be disposed  
 of by the aforesaid Commissioners or any five of them for the use aforesaid and if  
 the severall sheriffs or their Lawfull Deputies aforesaid or any of their deputies  
 aforesaid be found negligent in their Duty herein they shall be fined at the  
 Discretion of the said Commissioners or any five of them and the fines to be levied  
 and disposed of to the use intents and purposes before in this present Act menti-  
 oned **And be it further Enacted** by the authority aforesaid that the  
 severall sheriffs shall execute such warrants and Impraiment Juris Jurys as shall  
 be by the Commissioners aforesaid or any five of them Ordered to Issue Ex officio  
 without any fee or Reward for the same and the Deputy Surveyors aforesaid  
 are to lay out the said lands and lots aforesaid and to make a true  
 Draught of the Towns streets and lots therein and deliver the same to the  
 Commissioners to be Recorded for the fee of thirty pounds of tobacco off Lot-  
 tles in the said Recited Act is Directed at their percell and the said Commis-  
 oners or any five of them are hereby Impowered to Compell workmen Labourers  
 and others to <sup>help to</sup> carry the Chayn Cut stakes & assist in the Measuring  
 and staking out of the ground of the said severall hundred acres of  
 land at the Towns ports and places in this and the said Recited  
 Act appointed and if such workmen Labourers or others Impressed  
 or Comanded by the Commissioners aforesaid shall Refuse to assist in  
 work aforesaid he or they for Refusing shall be fined two hundred  
 pounds of tobacco to be levied on his goods and chattels for the use aforesaid  
 And if any person Returned a Juror shall at any time hereafter  
 Refuse or neglect to appear before the said Commissioners at the days  
 and places aforesaid to be appointed or appearing shall Refuse to serve as  
 a Juror man such person for Refusing or neglecting shall be fined  
 five hundred pounds of tobacco to be levied as aforesaid for the use  
 aforesaid And the said Commissioners or any five of them according  
 to their severall Divisions made amongst themselves as aforesaid  
 are to appoint such and so many persons in their severall Counties  
 and Divisions aforesaid as to them shall seem meet to keep the  
 Books of their proceedings in the premises and in the Execution of  
 of the said Act and entering the lots as to them shall seem meet  
 And whereas severall debates & differences have and may hereafter arise  
 in this province touching and concerning the proceedings of the
