M<sup>rs</sup> John Dobb now in possession of John Mould and y<sup>e</sup> land

 called Westbury's Point. In Dabolt County a port town or  
 place at or near y<sup>e</sup> Co<sup>st</sup> House upon y<sup>e</sup> land of James Downes.  
 In the land adjacent. to be called York. In the County of  
 Somerset a town or port at Snow Hill on y<sup>e</sup> land formerly  
 belonging to Henry Bishop and left to Sam<sup>l</sup> Bishop his widow  
 and one other in Arnold Erzys land of the land adjacent at  
 Byster Street at y<sup>e</sup> mouth of Monokin, and y<sup>e</sup> all persons that  
 have already built upon y<sup>e</sup> said land called Snow Hill shall  
 enjoy their lots as fully firmly & effectually as any other  
 builders upon lots in any other towns paying for y<sup>e</sup> same as  
 others do. In Dorchester County one in little Choptank River  
 at Nicholas & Maryes point. to be called Hington and one  
 other in Humber River on y<sup>e</sup> East side of y<sup>e</sup> said River on  
 Andrew Fulbyes Street to be called Bristol and in y<sup>e</sup> County  
 of Cecil one town port or place in Elk River at a place called  
 Cecil Town at y<sup>e</sup> mouth of Bohemia River and that y<sup>e</sup> Commission  
 in y<sup>e</sup> said Act for Advancement of Trade nominated or any fund of  
 them shall and hereby impowered to have y<sup>e</sup> full & ample  
 authority not only as to the purchasing & surveying laying &  
 staking out lots but as to the doing & performing of all and  
 every other thing & things whatsoever relating to y<sup>e</sup> new towns  
 herein mentioned as they had have or were intended to have  
 had by y<sup>e</sup> aforesaid two several Acts or either of them in relation  
 to those towns in y<sup>e</sup> said former Acts mentioned. To all intents  
 purposes whatsoever and the Commission in the said Act for  
 Advancement of Trade for each respective County nominated or  
 fund of them are hereby Impowered & Enjoyed some time before  
 y<sup>e</sup> twenty fifth day of March now next ensuing to meet together  
 upon the respective lands & places before in this Act before mention  
 ed to raise y<sup>e</sup> same to be laid out into lots in such manner & form as  
 y<sup>e</sup> said first recited Act is directed & following in all points and
