further Enacted by y^e Authority aforesaid that the
 taking up of y^e severall Letts in each respective County in this p^t sent
 Act mentioned complying with y^e general rules p^rscribed in y^e aforesaid Act
 before y^e last day of August w^{ch} shall be in y^e year one thousand six
 hundred eighty & eight are hereby imposed wth a life Estate in their
 severall respective Letts & shall hold & enjoy y^e same to them & their heirs
 in such manner & under the like rents as y^e other Letts in those parts &
 Counties in y^e former Acts are held or mentioned to be held & enjoyed
 and now in tender consideration of y^e necessity having Especiall regard
 to y^e p^t sent in incapacity of many y^e Inhabitants of this Province as
 to a plenary compliance wth all particulars required by y^e former Acts

Be it therefore further Enacted by y^e Right Hon^{ble}
 the Lord Prop^r by & with y^e advice & consent of y^e Upper Lower
 houses of this p^t sent Gen^l Assembly and y^e Authority of y^e same
 that from & after y^e publication of this p^t sent Act of Assembly within
 y^e last day of August in y^e year of o^r Lord one thousand six hundred
 eighty & eight no longer it shall & may be lawfull for any person or persons
 without the Substant^l or others living or residing in this Province
 by any means or wayes what soever to carry or transport their
