 forty shillings for y^e value of a hog's head of tobacco in other goods
 wares & merchandises to be recovered by action of debt bill plaint
 or information in any Court of this Province one third part thereof
 to y^e King's use one third part to y^e benefit
 of y^e Town next adjacent to y^e house habitation plantation of y^e owner
 of such tobacco or goods and y^e other third part to y^e informer or him or
 them that shall sue or sue for y^e same wherein no defence or
 wagers of Law to be allowed any thing matter or cause whatsoever
 arising aforesaid two severall debts before mentioned to y^e contrary here
 in any wise notwithstanding **And it is further Enacted**
 that y^e person or persons soe bringing y^e tobacco & goods to such
 port in case y^e officer cannot in y^e sloop number y^e hog's head
