An Act for preservation of Orphans reall estates

Whereas a good and profitable law was made at an Assembly held at the
 City of St^e Maries y^e tenth day of Octob^r in y^e fortieth year of y^e Dominion of y^e right
 Hon^oable Cecilius of noble memory and in y^e year of o^r Lord 1671. Entituled an
 Act for y^e preservation of Orphans Estate y^e wth said Act nor any other theretofore
 as yett made hath any wise effectually provided against wast sales or destruction committed
 of or upon y^e reall Orphans to wth dwelling houses out houses lands woods orchards
