Parliament; Entituled an Act for preventing frauds and regulating Abuses
in the Plantation Trade: or any other Statute Law of Eng^d any thing herein
Conteyned To y^e Contrary Notwithstanding

An act Prohibitting the Abuses Committed by Woods Rangers

For as much as divers Complainth has been made to this present
Gen^l Assembly of abuses Committed by such persons as have obtained Comissions
from the Governour to Range the Woods and Forrests After wild m^ork Cattle
and horses; And it is prayd that it may be Enacted. And be it Enacted by the
Kings most Excellent Majesty by and with Advice and Consent of this present
Gen^l Assembly and the Authority and the Authority of the same: That it shall &
may be lawfull for any person after the last day of July next to make Appli-
cation to the Governour for the time being To grant a Commission or to Exercise
or use any Commission to range as aforesaid: Except such person produce a
Certificate from under the hand of the Justices of y^e County Courts where the sd
person is to range: Testifying forth that he is of good fame: And be it further
Enacted by the Authority aforesaid by and with the Advice and Consent aforesaid
That no person Commissioned as aforesaid shall Depute any person as a Dep^y
to range the woods & Forrests after Cattle & horses as aforesaid: Except such
persons be likewise approved on by the Justices of the County in which he is to
Range as a Dep^y: And for as much as it will be necessary: That asett time should
be Appoynted to which Age horses and Cattle should be deemed Wild: Bee
it Enacted by the Authority aforesaid: and with the Advice and Consent a
Horse
