and Adjudged to all intents and purposes to demand Challenge & have  
enjoy all Landes Privileges hereditarily; And other rights and Priviledges  
as if they and every of them had beene Natural born Subjects of this Province  
And they and every of them are hereby Enabled to prosecute maintain Injurg.  
and Defend all manner of Actions, Suits, Pleas, Plaists: and demands whatsoever  
as fully and simply as if they and every of them had beene Natural born  
Subjects of this Province: any former Impediment or Disability in them or any  
of them: by reason of their being Natural born Subjects of this Province  
Provided that this Act or any thing herein contained shall not be construed or  
taken to Enable or Qualify the abovesaid Persons to Enjoy or hold any place  
office: calling: Employment Prohibited or not tolerated by the late Act of  
Parliament: Entituled an Act for preventing frauds and regulating Deales  
in the Plantation Trade: or any other Statute or Law of Eng<sup>l</sup>d any thing herein  
contained to the Contrary notwithstanding

## An act Prohibiting the abusee Committed by Wood Rangers

For as much as divers Complaints have been made to this present  
Gen<sup>l</sup>: Assembly of abuses Committed by such Personnes as have obtained Commission  
from the Governor to Range the Woods and Forrests after wild Cattle  
and horses: And it is prayed that it may be Enacted: And be it Enacted by the  
Kings most Excellent Majest<sup>y</sup> Board with Advice and Consent of this present  
Gen<sup>l</sup>: Assembly and the Authority and the Authority of the same: That it shall be  
may be lawfull for any Person after the last day of July next to make Application  
to the Governor for the time being to grant a Commission or to Exercise  
or use any Commission to range as aforesaid: Except such Person have a  
Certificate from under the hand of the Justices of 4 Countye (orcs where the said  
Person is to range) setting forth that he is of good forme: And be it further  
Enacted by the Authority aforesaid by and with the Advice and Consent aforesaid  
that no person Commissioned as aforesaid shall deputie any Person as aforesaid  
to range the Woods & Forrests after Cattle & horses as aforesaid: Except such  
Person be likewise approued by the Justices of the County in which he is to  
Range as aforesaid: And for as much as it will be necessary: That a sete of  
be Appointed to whiche Cattell horses and cattle shalbe deemed Wild: Be  
it Enacted by the Authority aforesaid: and with the Advice and Consent aforesaid
