And whereas the Inhabitants of S<sup>t</sup>. Maries County have  
Represented <sup>to this present</sup> General Assembly the Remoteness of the Situation  
of their County Court house from the greater part of the  
Inhabitants, which appeared to this General Assembly to be  
altogether inconvenient, and it is prayd the same might be  
Removed to some more convenient place for the ease of the  
greater part of the Inhabitants there, and whereas it is  
thought that the aforesaid Land called Shephards old fields  
near the center of the said S<sup>t</sup>. Maries County therefore prayd that it  
may be Enacted -

And be it Therefore Enacted by the authority aforesaid  
by and with the advice and Consent aforesaid that the County  
Court for S<sup>t</sup>. Maries County shall for the future be held and  
kept at the said Town to be erected in Shephards old fields as  
aforesaid And for building and erecting the said Court house  
the Commissioners aforesaid appointed for S<sup>t</sup>. Maries County or  
the major part of them are hereby authorized and Empowered  
to treat and agree with undertakers and workmen and to doe  
other matters and things that shall be thought Necessary for  
building and finishing the said Court house -
