Province doth consist in the love and affection of his people on which doth depende to receive upon all occasions for his supplies both by sea and land not doubtinge of their duty and
acted by the Lord Proprietary in the advise and assent of the upper and lower house of this present Assembly that noe subsidies aides Customs Taxes or Impositions shall hereafter

An Act concerninge the levyinge of
Warre within this Province

And be it enacted by the Lord Proprietary with the advise and assent of the upper and lower house of this present Assembly that if the Lord Proprietary or his heirs or any Deputy
of this Province shall at any tyme hereafter make any warre out of the limits or parts of this Province without the consent and approbation of the Great Assembly of this Province
or warre obliged or compelled against thers consent to aid or assist in the defence or states in the protection or maintenance of such warre But and also shall be
warre any lands or estate to the contrary herof in any wise notwithstandinge And doe further humbly praye that it maye be enacted And be it enacted by the
hereafter be exercised in this Province But only in tyme of Siege or Garrison and that in such Camps or Garrisons And be it further enacted by the authority
of the Province against any invasion of any enemy or enemies or against any domestic insurrection or rebellion against the publique peace of this Province or
any persons lands and Proprietaries of this Province shall be defrayed by this Province by an equal assessement upon the persons and estates of the Inhabitants thereof

of the upper and lower house of this Assembly that what person or persons shall at any tyme hereafter attempte to transporte or cause to be transported out of this Province any of the Ordnance
the value of twenty Shillings or upwards provided or to be provided from tyme to tyme hereafter by his Lord or his heirs Lord and Proprietaries of this Province or by a Great Assembly of the Inhabitants
and lawfull warrant from his Lord and his heirs Lord and Proprietaries of this Province for soe done under his and thers hands and Seals at Armes records and

in the consent and approbation of the upper and lower house of this Assembly that all debts which are or shall be from tyme to tyme statute and truly due
or due shall be first paid and satisfied within this Province before any other debts what soever /

An Act for the planting of Tobacco

the upper and lower house of this Assembly that every taxable person planting Tobacco shall plant and tend two acres of Tobacco upon pain of forfeiture to the Lord Proprietary for every two acres
of Tobacco for every halfe acre that hee shall fall short of that proportion provided that any person who shall have just cause why hee shall not plant and tend for more Tobacco
or more than one hundred and thirty pounds of Tobacco for every acre that hee shall fall short of that proportion aforesaid respectively to be divided equally between the
by every respective offender against this Act fifty pounds of Tobacco for every acre that hee shall fall short of that proportion aforesaid respectively to be divided equally between the
