

The same as aforesaid shall wilfully or otherwise neglect or refuse to
make sett up compleat & finish the said tobacco tiller & Caste aforesaid
such proportions & by such times as aforesaid shall forfeit the sume of
one hundred pds of tobacco for every tun of Caste or tobacco tiller lost at
the tyme aforesaid unmade not sett up & unfinished to be recovered in
the severall County Courts where the said party or parties Cooper or
Coopers doe at that tyme dwell & reside Unless the said Cooper or
Coopers person or persons agreeing or undertaking the said worke or
task aforesaid shall or can befor the Commissioners of such County Court
make itt sufficiently appeare that he was hindered in performing his
said Agreement or undertaking by sickness or some other lawfull
impedim^t to be adjudged & approved of by the said Com^s of the said
severall County Courts This Act to endure for these yeares or to the end
of the next Gen^l Assembly

An Act for the settling the Inheritance of the real Estate
of Robert Lager as alsoe his Personall Estate upon the
Mayor Recorder Aldermen & Common Councell of the City
of S^t Maryes & their Successors to the uses in the said Robert
Lagers will mentioned

Whereas Robert Lager late of S^t Georges Hundred in the County of
S^t Maryes County deceased was in his life tyme Seized in his Demise
as of Fee of severall parcels of land & Plantations situated lying
& being in S^t Maryes Somersett & other Counties within this Province
& alsoe possessed of a Personall Estate to a good Value He the said
Robert Lager being soe Seized & possessed did make his last Will and
Testament in Writing bearing date the Twenty fourth day of
January 1678 & therein & thereby amongst other things did
Devise Give & bequeath all his Estate both Real & Personall
Estate moveables & immovables lands & Tenements by what name
or title soever called or any way appeare to be his (his debts being
first well satisfied contented & paid) unto the Inhabitants of S^t
Georges & Poplar Hill Hundreds in the aforesaid County & to their
Survivors & Successors forever for maintaining of a Protestant
Ministry from tyme to tyme amongst them as they the Inhabit^{ts}
of the said Hundreds or the Mayor & Officers shall approve of for
their Minister & Teacher The Freeholders of the said two hundreds
or the major part of them to Elect Induct & approve of such from
tyme to tyme to be their Minister & Teacher that he soe admitted
to enjoy the benefit of the said Estate soe ordered & given as aforesaid
And he did thereby Constitute & Appoint M^r Francis Southwell
George Macall & M^r Peter Watts to be his lawfull Executors to see the
performance of his last Will & they to nominate such after them
as might see to the carrying on & prosecuting from tyme to tyme
