 & consent of the upper & lower houses of this present Gen^l Assembly
 That from Easter the publication hereof no Officer or Officers hereafter
 mentioned in this present Act their Ministers Servants or Deputies
 by reason or colour of his or their Office or Offices have receive or
 take of any person or persons directly or indirectly any other Fees
 then by this Act is hereafter limited & allowed to the severall
 Officers hereafter mentioned —
