 Vouch'd & aforesaid provided the aforesaid such person shall be fined  
 the summe of Two hundred pounds of Cobrino, and alsoe every person that  
 shall strike any ffeble aforesaid whethers by day or night the summe  
 of One hundred pounds of Cobrino for every ffeble soe strucke. One halfe  
 of which land earth of which said ffebles to be paid to ye Informer and  
 ye other halfe to our Lordes quare lady ye Queen their Maister or  
 Justice to be Imployed by ye Justices of ye County where ye Offender  
 livet towardes ye defacinge ye Chirches of our Country, such ffeble or  
 ffebles to be payed by ye Castle of our Justitient All the feareles besidē  
 ye Informer before One or more Justices or Justices of ye peace who  
 upon Complaint therof made shall issue out his warrant to ye  
 Constable of ye hundred or to such other person or persons as such  
 Justice or Justices shall think fit to bring before him or them  
 ye person or persons against whom such Complaint shall be made  
 and ye witness or witnessess which ye Complainant shall name  
 which Justice or Justices shall have full Authority by Certificate  
 this Act to heare and determine ye matter and upon such proof  
 ye Justice or Justices shall pronounced or their Warrant to ye  
 Sheriff of such County to levy ye same fine by disfesse and  
 sale of ye ~~Bleeding~~ Goods and Chattells of ye person or persons  
 having the Offended And in Default of goods or Chattells to be  
 thrown by such Offender or Offenders to such Sheriff that  
 he or she Sheriff shall be and is hereby Empowered to levy  
 ye same upon ye body or bodies of him or them and shall on  
 receipt of such fine forthwith pay One shillings of such fine to  
 ye Informer and reward and remun of ye other halfe to the  
 Justices of such County at ye time of ye taking ye same next day  
 for such County to be payed towardes ye defacinge ye same County  
 charge aforesaid

PROVIDED herelbasse That in Case any Servant or  
 Slave shall be Attayned of any Hurt prohibited by this Law and  
 that it shall appear to ye Justice or Justices before whom such  
 Attaynation shall be made or Examined That such Servant or Slave  
 is guilty of ye hurt wherof he or she shall be therfore attayned  
 but that such Hurt was committed by ye direction of Order or  
 Approbation of ye Master Mistris Dame or Overseer of such Servant  
 or Slave that then such Master Mistris Dame or Overseer  
 shall upon Conviction of such direction or Order or Approbation aforesaid  
 in manner above described be liable to ye same for failure  
 if such Hurt had been personally committed by ye person soe  
 directing Ordering or Approbating ye same, But if such Hurt  
 shall appear to such Justice or Justices aforesaid to have been  
 voluntarily committed by such Servant or Slave without any such  
 direction or order or approbation aforesaid Then then such Servant  
 or Slave being therof Convict there of, in manner aforesaid  
 shall in default of ye payment of ye fine or fines aforesaid  
 be Imposed, forthwith suffer corporall punishment by being  
 whipt with 5000 stripes on his or her bare backe, & to such
