

W<sup>h</sup>ic<sup>h</sup> Act in a Supplementary Act to y<sup>e</sup> Act for Amendment of Justice  
 and Erecting ports and Docks made at a Session of Assembly begun and  
 held at y<sup>e</sup> Down and port of Chingly the 20<sup>th</sup> day of March  
 Anno Dom<sup>i</sup> One Thousand Seven Hundred and seven amongst other things  
 in y<sup>e</sup> said Act contained, It was Enacted by y<sup>e</sup> ~~King~~ ~~and~~ ~~Parliament~~  
 and Authority therein mentioned that y<sup>e</sup> place appointed for a Town on Gunpowder  
 River on y<sup>e</sup> Land called Hesters here should be deserted in Lieu thereof  
 fifty Acres of Land should be erected into a Town on a Tract of Land  
 on y<sup>e</sup> said River belonging to John Hester called Enylford Thome And that  
 a Court house of y<sup>e</sup> said County should be built there, And forasmuch  
 as there was no other provision made for y<sup>e</sup> building of y<sup>e</sup> said Court  
 house than what was contained in said Act, And for that y<sup>e</sup> said Act is  
 not now in force and to be observed it had been Represented to this  
 Generall Assembly that y<sup>e</sup> Justice of said County had proceeded toward  
 y<sup>e</sup> building of said Court house according to y<sup>e</sup> Direction of y<sup>e</sup> aforesaid  
 Act before her Majesty's discontent y<sup>e</sup> same would be done and have since  
 y<sup>e</sup> said County to be well nigh finished And for that y<sup>e</sup> Situation of y<sup>e</sup>  
 said house is represented to be convenient to y<sup>e</sup> said County It is  
 therefore humbly prayed that y<sup>e</sup> Court of y<sup>e</sup> said County may by an Act  
 for that purpose be appointed to be there in y<sup>e</sup> said County

Be it therefore Enacted by y<sup>e</sup> Queen's most Excellent Majesty  
 by and with y<sup>e</sup> Advice and Consent of her Majesty's private Council and  
 Assembly of this Province and y<sup>e</sup> Authority of y<sup>e</sup> same, that  
 Baltimore County Court shall be from henceforth held at y<sup>e</sup> said  
 house now built at y<sup>e</sup> said Town of ~~Enylford~~ and not elsewhere, And  
 that y<sup>e</sup> same house be to all Intents Constraints purposes and Judgments  
 of Law reputed and taken as y<sup>e</sup> proper Court house of Baltimore  
 County, and that all liases ~~of~~ ~~land~~ out by virtue of y<sup>e</sup> said  
 Act for some for y<sup>e</sup> said ~~County~~ shall be and is hereby declared  
 to be and remaine so and for y<sup>e</sup> same uses and Intents as y<sup>e</sup> same  
 were laid out for. And forasmuch as writts of Election have been  
 lately sent to y<sup>e</sup> Sheriff of Baltimore County to cause y<sup>e</sup> same to be  
 to be elected for y<sup>e</sup> said County to represent them in this next Generall  
 Assembly and deliberation of y<sup>e</sup> said Province it is already made to be  
 held at Gunpowder here where y<sup>e</sup> old Court house for y<sup>e</sup> said  
 County was

Be it Enacted by y<sup>e</sup> Authority Advice and Consent aforesaid  
 that y<sup>e</sup> said Election now to be made shall be held and made  
 according to y<sup>e</sup> Statutes aforesaid published in any Law Statute  
 or Usage to y<sup>e</sup> contrary hereunto notwithstanding

And to prevent y<sup>e</sup> discontinuance of y<sup>e</sup> aforesaid in y<sup>e</sup> said  
 County Court by means of y<sup>e</sup> Attendance of y<sup>e</sup> Justice thereof at this  
 next Generall Assembly

Be it Enacted by y<sup>e</sup> Authority aforesaid and with y<sup>e</sup>
