W<sup>e</sup>ll C<sup>o</sup>m<sup>it</sup> in a Supplementary Act to ye<sup>r</sup> Act for the Amendment of Deed  
and Existing Deeds made at a Session of Assembly begun and  
held at ye<sup>r</sup> Town and Port of Baltimore the Twenty Fifth day of March  
Anno Domini One thousand Seven hundred and eleven amongst other things  
in ye<sup>r</sup> said Act contained, It was Enacted by ye<sup>r</sup> ~~C<sup>o</sup>m<sup>it</sup>~~ ~~De~~ ~~Co~~ ~~As~~ ~~Se~~  
and Authority thereon mentioned that ye<sup>r</sup> place appointed for a Town on Gunpowder  
River on ye<sup>r</sup> land called Eborad North Should be deserted in Sion Shore  
fifty acre of Land Should be erected into a Town on a Part of Land  
so called River belonging to him called Eborad Towne And that  
the Court house of ye<sup>r</sup> said County Should be built there, And for sume  
there would no other provision made for ye<sup>r</sup> building of ye<sup>r</sup> Court  
house than what was contained in said Act, And for that ye<sup>r</sup> Act is  
not now in force and wherefore it had been represented to this General  
Assembly that ye<sup>r</sup> Justices of ye<sup>r</sup> said County had proceeded toward  
ye<sup>r</sup> building of ye<sup>r</sup> Court house according to ye<sup>r</sup> direction of ye<sup>r</sup> aforesaid  
Act before his Majestys arrival to ye<sup>r</sup> extreme woe & trouble and have since  
proposed to be well nigh finisht and for that ye<sup>r</sup> situation of ye<sup>r</sup>  
said County is represented to be convenient to ye<sup>r</sup> County It is  
therefore humblye prayed that ye<sup>r</sup> Court of ye<sup>r</sup> same County may by ye<sup>r</sup> Act  
for that purpose be appointed to be held in ye<sup>r</sup> said County

Be it therefore enacted by ye<sup>r</sup> Queen most Excellent Majes-  
ty and with ye<sup>r</sup> Advice and Consent of the Majest<sup>y</sup> profit Comit and  
Assembly of this Province and ye<sup>r</sup> Authority of ye<sup>r</sup> same, that  
Baltimore County Justices shall from henceforth hold at ye<sup>r</sup> said  
County town till it be fit for ye<sup>r</sup> new Court house of Baltimore and not elsewhere; And  
that ye<sup>r</sup> aforesaid Justices shall hold their Court house of Baltimore  
at Eborad and Etoway daye proper Court house of Baltimore  
County, And that all those costs of ye<sup>r</sup> Court house by virtue of ye<sup>r</sup> said  
Act to come for ye<sup>r</sup> putting effect shall be and is hereby deforded  
to ye<sup>r</sup> and remaine to such for ye<sup>r</sup> same daye and Intended by ye<sup>r</sup> same  
expended out for. And whereas summe 118 L. 10 s. 10 d. of Etoway  
latey sent to ye<sup>r</sup> Justices of Baltimore County to be expended  
to ye<sup>r</sup> Etoway for ye<sup>r</sup> County to represent them in their present General  
Assembly and solicitation of ye<sup>r</sup> Etoway is already made to be  
held at Gunpowder North before ye<sup>r</sup> Old Court house for ye<sup>r</sup> said  
County where.

Be it further enacted by ye<sup>r</sup> Assembly advice & consent aforesaid  
that ye<sup>r</sup> Etoway now to be made shall be held and made  
according to ye<sup>r</sup> constitution aforesaid published by ye<sup>r</sup> Law Statute  
or otherwise to ye<sup>r</sup> contrary notwithstanding.

Also whereof ye<sup>r</sup> Justices of ye<sup>r</sup> Baltimore County by ye<sup>r</sup> direction of ye<sup>r</sup> Justices of ye<sup>r</sup> said  
County by ye<sup>r</sup> direction of ye<sup>r</sup> Assembly of ye<sup>r</sup> said County.

Be it enacted by ye<sup>r</sup> — — — Authority aforesaid and with ye<sup>r</sup>  
Advice and Consent aforesaid that all writs Suits & actions pleas presented
