 Seven Hundred Acres called Team Drift to her ye said Anne
 Coult and her Heires of her body lawfully begotten for ever,
 And on failure of such Heires to ye right Heires of me ye said
 John Coult forever, Also two hogrees namely Tony with her future
 Increase also four Cows and Calves Six Ewes and Lambs with
 them Six Towes and a Boare And seven pound Sterling to buy her
 ye said Anne Coult a silver Tambour And One good feather
 Bed and Furniture to her ye said Anne Coult her Heires and

 parts of Land or parcels One of them lying upon Solomons
