

pannis & desperate debts at the discretion of the Comissary Genall not
 exceeding five p Cent on any one Mans Estate. But for such part of
 the deceased Estate that shall remain (after all debts & Charges paid
 & disbursed & ac. paid before the Comissary Genall) to residuary
 Legatees or other Legatees or next of kinred & delivered to them in
 specie without traversing the Estate & Converting it into money or
 Tobacco for that purpose there shall be no salary allowed any usuaq
 Custome or former act of assembly to the contrary notwithstanding
 Thirteenth — And further in regard by the Judge or Comissary
 Genall for probat of Wills & granting admistrations his Comission
 there is a saving to all persons their right of appeal from the sentence
 of the said Judge to the Cheife Govern^r of this Province for the time being
 Pre it enacted by the Authority aforesd. by & with the advice and
 Consent aforesd. that all & every person & persons appealing from the
 sentence of the sd Judge shall within fifteen days at the farthest
 after such sentence enter his appeal before the sd Governour and within
 fifteen days more petition the Governour of this Province for the
 time being to examine the sentence of the said Judge or appoint such
 other person or persons as he shall think fitt to hear & determine the
 same whose sentence shall be final without other Appeals or review
 Provided nevertheless that in case the person or persons against
 whom such sentence shall pass shall comply with the same. then
 it shall & may be lawfull for the Gov^r or such Court of Delegates
 to grant an Appeal therefrom — And be it further enacted
 by the Authority aforesd. by & with the advice & Consent aforesd. that
 the Comissary Genall of this Province or other person or persons
 that shall be from time to time appointed as Judge or Judges in tes-
 tamentary Causes for granting adm^{ts}ions shall from time to time
 & at all times during his or their continuance in such Office
 constitute Ordain & appoint some able & sufficient person of
 good repute & a freeholder in every respective County within this
 Province to take the probat of any last Will & Testament of any
 persons either in Execution or in Writing even tho the same be
 Concerning titles of Land & likewise to grant adm^{ts}ion of the goods
 & Chattells of persons dyeing intestate in the respective County
 or County's where each person or persons so appointed shall reside
 & inhabit which said person in each respective County of this
 Province so appointed as aforesd. shall & may take the proove of any
 Will whatsoever as aforesd. of any person as aforesd. within the County
 as aforesd. and grant letters Testamentary upon the same & likewise grant
 adm^{ts}ion to any person or persons whatsoever that right has to the
 Administration of the Estate of any person deceased within the County
 where he dwelleth as aforesd. but if any Contest or dispute shall arise
 between any persons Concerning the right to adm^{ts}ions or Executorship
